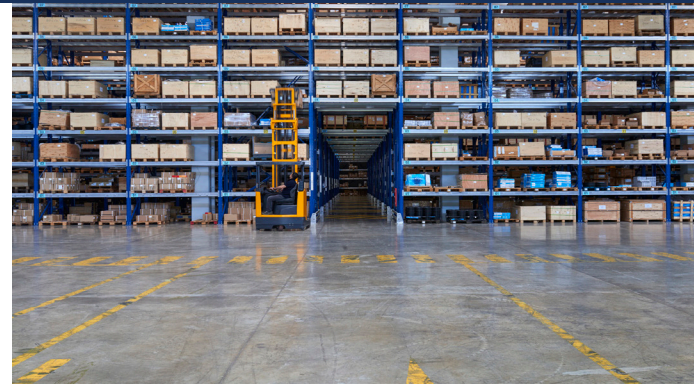

- Limits: \$1M / \$2M / \$2M - \$2M / \$4M / \$4M - alternative limits considered
- Deductibles or SIRs considered
- Minimum attachment \$25,000
- Minimum premium: \$100,000
- Alternative structures considered (i.e., fronted policies)
- Emphasis on accounts with claims severity, not frequency
- Umbrella / Excess Liability can be considered

- 2341 - Women's, Children's, and Infants Underwear and Nightwear
- 2361 - Girls', Children's, and Infants' Dresses, Blouses and Shirts
- 2369 - Girls', Children's, and Infants' Outerwear, Not Elsewhere Classified
- 2511 - Wood Household Furniture, except Upholstered (Cribs, Playpens, Car Seats)
- 2514 - Metal Household Furniture (Cribs, Playpens, Car Seats)
- 3942 - Toy Companies - Dolls and stuffed Toys Manufacturing
- 3944 - Games, Toys and Children's Vehicles Manufacturing (Strollers, etc.)
- 5092 - Toys and Hobby Goods and Supplies Wholesale Distribution
- 5137 - Women's, Children's, and Infants Clothing and Accessories
